CHANGES TO THE ACCOUNT****

- If changing name on account send copy of documents indicating name change: (marriage license, etc.)
- Complete all fields on the signature cards
- If Joint account complete joint member's information
- Send a copy of the front and back of a valid picture ID for each person on the account
- A valid street address must be verified if different from identification. (Water, electric and phone bills, military orders assigning personnel to any U.S. duty station can be used for verification.) Members can use a P.O. Box only for the purpose of receiving mail.
- If changing a name, removing a joint member or adding a joint member, you must complete a share draft agreement if there is a share draft account currently open.
- Please be sure to list a daytime phone number that you can be reached in case there are any questions.
